BY-LAW

Number 173-2009

To amend Traffic By-law 93-93,
By amending Schedules relating to
**DESIGNATED TURNING LANES, NO PARKING
AND DESIGNATED BICYCLE LANES**

The Council of The Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule VI thereto the following items:

DESIGNATED TURNING LANES

| COLUMN 1 HIGHWAY | COLUMN 2 BETWEEN | COLUMN 3 LANE | COLUMN 4 DIRECTION | COLUMN 5 COMPULSORY TURN |
|-----------------------|---------------------------------------|------------------|-----------------------|--------------------------------|
| Rutherford Road North | Williams Parkway and Carl Dalli Court | Right Lane | Northbound | Right turn |

(2) by adding to Schedule VI thereto the following items:

DESIGNATED TURNING LANES

| COLUMN 1 HIGHWAY | COLUMN 2 BETWEEN | COLUMN 3 LANE | COLUMN 4 DIRECTION | COLUMN 5 COMPULSORY TURN |

| Rutherford Road North | Carl Dalli Court and Bruce Beer Drive (North intersection) | Centre | Southbound | Left |
| Rutherford Road North | Archdekin Drive (North intersection) and Bruce Beer Drive (South intersection) | Centre | Northbound & Southbound | Left |
| Rutherford Road North | 21 metres north of Vodden Street to a point 35 metres north thereof | Centre | Northbound & Southbound | Left |
| Rutherford Road North | Herkley Drive and Reigate Avenue | Centre | Northbound & Southbound | Left |

(3) by deleting from Schedule XIV thereto the following items:

NO PARKING

| COLUMN 1 HIGHWAY | COLUMN 2 SIDE | COLUMN 3 BETWEEN | COLUMN 4 TIMES OR DAYS |
|--------------------------|------------------|---|--|
| Rutherford Road North | West | A point 15 metres north of Archdekin Drive (southerly intersection) and Williams Parkway | 7:00 am to 9:00 am Mon to Fri inclusive |
| Rutherford Road North | East | A point 15 metres north of Archdekin Drive (southerly intersection) and Williams Parkway | 4:00 pm to 6:00 pm Mon to Fri inclusive |

(4) by adding to Schedule XXX thereto the following items:

DESIGNATED BICYCLE LANES

| COLUMN 1 HIGHWAY | COLUMN 2 BETWEEN | COLUMN 3 LANE | COLUMN 4 DIRECTION |
|--------------------------|---|--|-----------------------|
| Rutherford Road North | Williams Parkway and Archdekin Drive (south intersection) | Adjacent to parking lane or curb lane | Both |
