Brampton Transit System.

WHEREAS pursuant to Section 354 (1) 90 of The Municipal Act, R.S.O. 1970, Chapter 284, as amended, the Council of a local municipality may pass By-laws for operating a public bus transportation system and for making regulations with respect to the operation and control of the system.

NOW THEREFORE, the Council of the Corporation of the City of Brampton hereby ENACTS as follows:

- 1. In this By-law:
  - "Brampton Transit" shall mean the bus transportation system established by the Corporation of the City of Brampton.
- No person shall smoke, carry lighted pipes, cigars and cigarettes on any vehicle, or expectorate or commit any nuisance or use foul or obscene language in or upon any vehicle or premises of Brampton Transit.
- 3. No person shall ride or stand on any exterior portion of any vehicle operated by Brampton Transit, nor lean out of, nor project any portion of his body or any article through any window or other opening of any vehicle of Brampton Transit.
- 4. No person other than an official or employee of Brampton

  Transit shall handle or operate any vehicle or any part of the electrical or mechanical equipment of any vehicle operated by Brampton Transit except devices which are intended for passenger use.

- 5. Every person, upon entering into any vehicle of Brampton Transit, shall directly deposit in the fare box, a fare established from time to time by resolution of the Council of the Corporation of the City of Brampton.
- 6. Any person depositing in the fare box less than the posted fare shall be deemed to be refusing to pay the fare.
- 7. No person shall sell, exchange or give away a transfer or accept or use any transfer except if it has been issued to that person upon payment of the posted fare.
- 8. No person shall remove from any vehicle or premises of Brampton Transit any valuable or article left therein through apparent inadvertence, but such valuable or article shall be left in the possession of Brampton Transit for disposition according to law.
- 9. No person shall sell, or attempt to sell, any newspaper, magazine, merchandise or any other article or thing, or distribute or give away any pamphlet, literature, or thing or solicit members of the public for any purpose whatsoever in any vehicle or premises of Brampton Transit except by permission of Brampton Transit first obtained in writing.
- 10. No person, except in the conduct of Brampton Transit business, shall operate any radio, tape recorder or similar device in or upon any vehicle or premises of Brampton Transit unless the sound therefrom is conveyed to that person by an earphone.
- 11. Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law.

Being a By-law to regulate the operation and control of the Brampton Transit System.
