To change the name of
Renault Boulevard

WHEREAS the Council of the Corporation of the City of Brampton deems it expedient to change the name of Renault Boulevard;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four successive weeks in The Brampton Times, a newspaper having general circulation in the City of Brampton;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:


1. The name of the street known as "Renault Boulevard" which is described in Schedule A attached hereto, is changed to "Chrysler Drive".

2. The affidavit of Leonard J. Mikulich as to compliance with the provisions of paragraph 105 of section 210 of the Municipal Act is attached as Schedule B and forms part of this by-law.


