# BY-LAW

*Number* 179-86

To amend By-law 4-83  
respecting the City of  
Brampton Safety Council

---

WHEREAS the Council of The Corporation of the City of Brampton enacted By-law 4-83, which established and created terms of reference for the City of Brampton Safety Council;

WHEREAS it is deemed expedient to expand upon the terms of reference of the Safety Council;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:


1. By-law 4-83 is hereby amended as follows:

- (1) by adding the words "and the Bicycle Safety Subcommittee" after the words "Safety Council" in the second line of clause 4(b);
- (2) by deleting clause c) of section 5 and substituting therefor the following:


"c) To develop, implement and assist with programs conducted both in and outside the schools promoting safety awareness, pedestrian education and bicycle safety";
- (3) by deleting clause f) from section 5;
- (4) by adding after clause 6 b) the following sections:
  - "7. a) To assist in fulfilling its responsibilities relating to bicycle safety, the Safety Council may by resolution appoint a Bicycle Safety Subcommittee which shall report to the Safety Council.
  - b) The Bicycle Safety Subcommittee shall consist of between five and nine members, at least three of whom shall be members of the Safety Council.
  - c) The Safety Council shall appoint the chairman of the Bicycle Safety Subcommittee from the Safety Council representatives to the Subcommittee, and may appoint such other persons as the Safety Council deems necessary to serve as members of the Subcommittee. Members of the Subcommittee shall hold office during the calendar year in which they are appointed and until their successors are appointed.

- d) The Bicycle Safety Subcommittee shall perform such tasks as are assigned by resolution of the Safety Council. The Safety Council may only delegate to the Bicycle Safety Subcommittee those tasks which are consistent with the Safety Council's responsibilities relating to bicycle safety as established by By-law 4-83 as amended.
- e) The Bicycle Safety Subcommittee shall meet once each month if required.
- 8. The Safety Council may receive contributions from individuals, service clubs and similar community groups to be used for the purposes of the Safety Council. Such funds shall be turned over to the City Treasurer for safekeeping and shall be reflected in the annual estimates and financial statements of the Safety Council.
- 9. The Safety Council shall report to the Public Works Committee of the City Council, and any recommendations forwarded by the Safety Council to the Public Works Committee shall be accompanied by all technical reports commissioned by, submitted to and considered by the Safety Council."
