WHEREAS the Council of The Corporation of the City of has, by resolution, decided that all constructed and installed in accordance with the subdivision agreement for Registered Plan 43M-520 be accepted and assumed;

AND WHEREAS Council has authorized the City Treasurer to release all securities held by the City in connection with the development of Registered Plan 43M-520;


AND WHEREAS, it is deemed expedient to accept and assume the streets on Registered Plan 43M-520 as part of the public highway system and to establish certain other lands as a public highways;

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby ENACTS as follows:

- The lands described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.
- The lands acquired by The Corporation of the City of Brampton and described in Schedule B to this by-law 2. are hereby established as public highways.
