Number 179-94

To amend By-law 93-93 to regulate use of highways and parking in the City of Brampton

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from the specified columns of Schedule III thereto the following items:

THROUGH HIGHWAYS

| COLUMN 1 HIGHWAY | COLUMN 2 BETWEEN |
|-----------------------|--|
| Rutherford Road North | The east limit of Kennedy Road North and the east limit of Weybridge Trail (westerly intersection) |
| Rutherford Road North | The west limit of Wikander Way (westerly intersection) and the south limit of Herkley Drive |

(2) by deleting from the specified columns of Schedule IV thereto the following items:

STOP SIGNS

| COLUMN 1 INTERSECTION | COLUMN 2 FACING TRAFFIC |
|--|------------------------------------|
| Rutherford Road North and Winterfold Drive (easterly intersection) | Westbound on Rutherford Road North |

| Rutherford Road North and Winterfold Drive (easterly intersection) | Southbound on Winterfold Drive |

(3) by adding to the specified columns of Schedule III thereto the following items:

(5) by adding to the specified columns of Schedule IX thereto the following item:

PEDESTRIAN CROSSOVERS

| COLUMN 1 HIGHWAY | COLUMN 2 LOCATION |
|-----------------------|--|
| Rutherford Road North | At the east side of Rutherford Road North and Winterfold Drive (easterly intersection) |

(6) by adding to the specified columns of Schedule X thereto the following item:

RATE OF SPEED

| COLUMN 1 HIGHWAY | COLUMN 2 RATE OF SPEED | COLUMN 3 BETWEEN |
|---------------------|---------------------------|---|
| Flowertown Avenue | 40 | Chinguacousy Road and McLaughlin Road North |


(7) by adding to the specified columns of Schedule XIV thereto the following item:

NO PARKING

| COLUMN 1 HIGHWAY | COLUMN 2 SIDE | COLUMN 3 BETWEEN | COLUMN 4 TIMES OR DAYS |
|--------------------------|------------------|---|---------------------------|
| Rutherford Road North | South | Weybridge Trail (westerly intersection) and Winterfold Drive (easterly intersection) | Anytime |

2. Subsections 1 (1), (2), (3), (4), (5) and (6) of this by-law shall not come into force until approved by the council of The Regional Municipality of Peel.

READ a FIRST, SECOND, and THIRD TIME and PASSED in OPEN COUNCIL, this 12th day of September, 1994 .





| Flowertown Avenue | 40 | Chinguacousy Road and McLaughlin Road North |


(7) by adding to the specified columns of Schedule XIV thereto the following item:

NO PARKING


| COLUMN 1 HIGHWAY | COLUMN 2 SIDE | COLUMN 3 BETWEEN | COLUMN 4 TIMES OR DAYS |
|--------------------------|------------------|---|---------------------------|
| Rutherford Road North | South | Weybridge Trail (westerly intersection) and Winterfold Drive (easterly intersection) | Anytime |

2. Subsections 1 (1), (2), (3), (4), (5) and (6) of this by-law shall not come into force until approved by the council of The Regional Municipality of Peel.
