AMENDMENT NUMBER 219 TO THE OFFICIAL PLAN OF THE CITY OF BRAMPTON PLANNING AREA

1.0 Purpose:

The purpose of this amendment is to delete from a policy in the Sandringham-Wellington Secondary Plan the requirement for Pedestrian/Cyclist underpasses at Dixie Road and Bramalea Road where they abut the TransCanada pipeline and to amend the policy to make the requirement for a Pedestrian/Cyclist crossing at Highway Number 410 at the discretion of the City.

2.0 Location

The lands subject to this amendment involve all of the lands contained in the Sandringham-Wellington Secondary Plan which encompass a total area of approximately 1,630 hectares (4,030 acres) bounded by Bovaird Drive on the south, Heart Lake Road on the west, Countryside Drive on the north and Airport Road on the east and comprise all of Lots 11 to 15 of Concession 3, 4, 5 and 6, E.H.S., in the geographic Township of Chinguacousy, now in the City of Brampton.

3.0 Amendment and Policies Relative Thereto:

The document known as the Official Plan of the City of Brampton Planning Area is hereby amended:

- (1) by adding to the list of amendments pertaining to Secondary Plan Area Number 28 set out in subsection 7.2.7.28, Amendment .
- (2) by deleting policy 6.4.4 of Chapter 28 of Part IV and substituting therefor the following:
 - "6.4.4 Pedestrian/cyclist movement along the TransCanada pipeline shall be facilitated by means of the following measures:
 - o The Minor Collector Road crossing of
 Torbram Road adjacent to the TransCanada
 pipeline shall be located to directly abut
 the pipeline to facilitate
 pedestrian/cyclist crossings of Torbram
 Road at that location.

o A pedestrian/cyclist crossing may be required under or over Highway Number 410 in the vicinity of the pipeline in conjunction with surrounding development, if determined necessary by the City."
