To amend By-law 200-82 for
part of Lot 8, Concession 1,
W.H.S. (R.P. 43M-476)

The Council of The Corporation of the City of Brampton ENACTS
as follows:

1. By-law 200-82, as amended, is hereby further amended:
 - (1) by changing the zoning designation of the land shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE FAMILY D-SECTION 205 (RD - SECTION 205) to HIGHWAY COMMERCIAL ONE-SECTION 165 (HC1 - SECTION 165), such land being part of Lot 8, Concession 1, W.H.S. in the former Town of Brampton, now in the City of Brampton.
 - (2) by deleting sheet number 6 of Schedule A thereto, and substituting therefor Schedule B to this by-law.

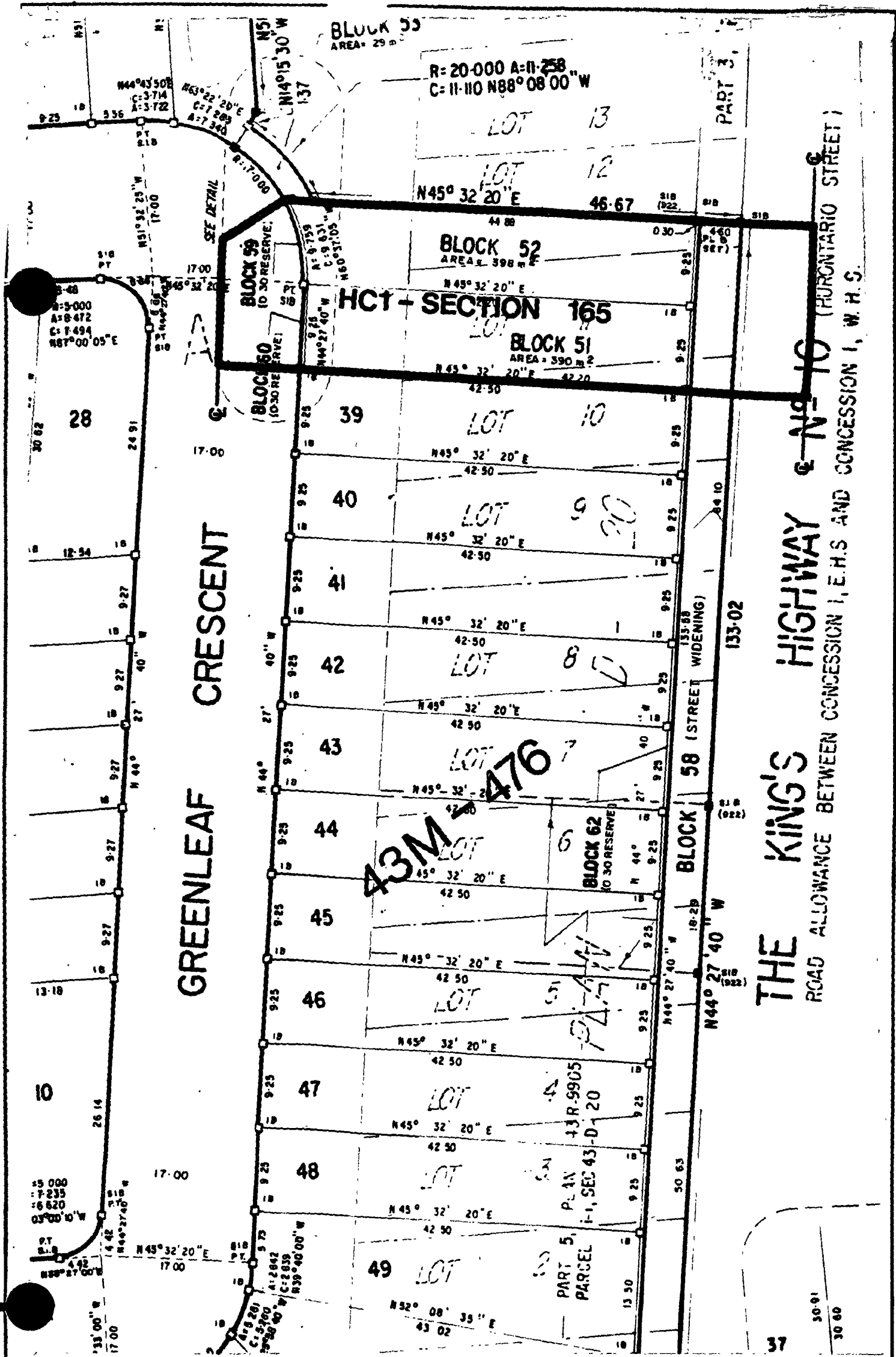
READ a FIRST, SECOND and THIRD TIME and PASSED IN OPEN COUNCIL.

PART LOT 8, CONCESSION 1 W.H.S.

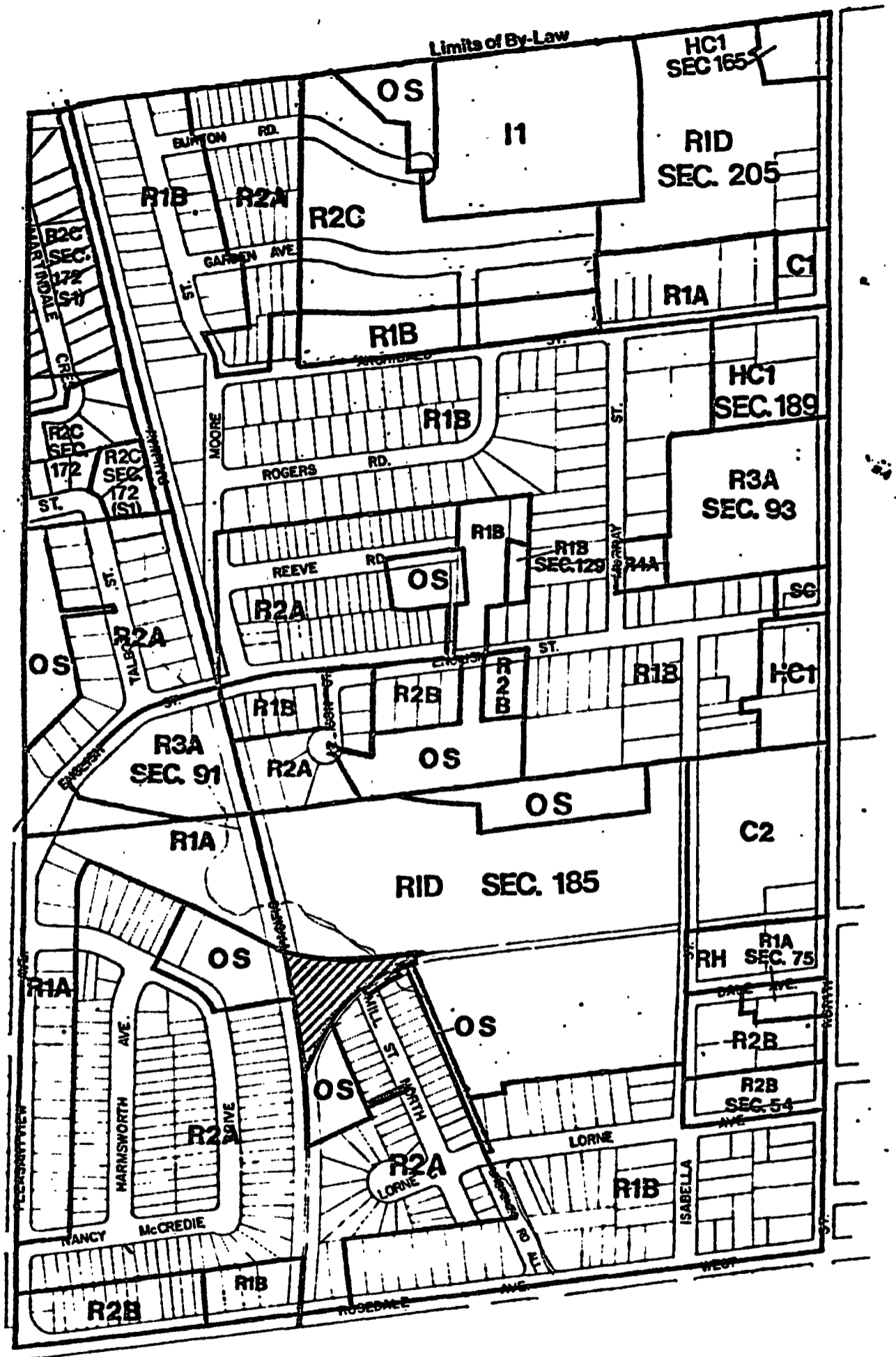


DECLARATION
