MEMORANDUM OF AGREEMENT made in duplicate this 14th. day of August , 1978.

BETWEEN:

RUSHVILLE CONSTRUCTION LIMITED

hereinafter called the 'Owner'

OF THE FIRST PART

AND

THE CORPORATION OF THE CITY OF BRAMPTON

hereinafter called the 'City'

OF THE SECOND PART

A N D

THE REGIONAL MUNICIPALITY OF PEEL

hereinafter called the 'Region'

OF THE THIRD PART

AND

CHARLES CASSIN

hereinafter called the 'Mortgagees'

OF THE FOURTH PART

WHEREAS the parties hereto entered into a subdivision agreement dated the 14th day of April, 1977 (herein called 'the agreement') with respect to the development of lands more particularly described in Schedule 'A' attached hereto in accordance with the Minister of Housing's conditions of approval dated the 19th day of January, 1976 (herein called the conditions');

AND WHEREAS the Ministry of Housing by letter dated the 14th day of June, 1978 has changed the conditions and this agreement is entered into for the purpose of amending the agreement to reflect these changes.

NOW THEREFORE THIS AGREEMENT WITNESSETH that the parties hereto agree each with the other as follows:

The agreement is amended by:

- deleting Schedule 'B' attached to the agreement and substituting in its place, Schedule 'B' attached to this agreement.
- (b) deleting paragraph 56 of the agreement and substituting in its place, the following paragraph 56:
 - 56. The Owner agrees that tempory turning circles shall be established by the conveyance of easements to the City as shown on the revised approved plan and which easements shall be held by the City until the road allowance has been produced, at which time the City shall release the easements to the owners of the land affected by them.
- The lands affected by this agreement are more particularly described in Schedule 'A' attached hereto.
- In all other respects the parties hereto confirm the terms of the agreement.




LEGAL DESCRIPTION OF THE LANDS


