The Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. Schedule A of By-law 861, as amended, is hereby amended by changing the zoning classification of the lands shown outlined on Schedule A to this by-law from AGRICULTURAL CLASS 1 (A1) to INDUSTRIAL SELECT 5 SECTION 448 (M5 SECTION 448) and CONSERVATION AND GREENBELT (G).
- 2. Schedule A to this by-law is hereby attached to By-law 861 as part of Schedule A, and forms part of By-law 861.
- 3. By-law 861, as amended, is hereby further amended by adding thereto the following section:
  - "448 The lands designated M5 Section 448 on Schedule A to this by-law:
    - 448.1.1 shall only be used for:
      - (a) the purposes permitted in a M5 zone
      - (b) purposes accessory to the other permitted purposes
    - 448.1.2 shall be subject to the following requirements and restrictions:
      - (a) no storage shall be permitted outside a building in an area located closer than 25 metres to the east limit of Torbram Road
    - shall also be subject to the restrictions and requirements relating to the M5 zone which are not in conflict with the ones set out in section 429.1.2."


