# BY-LAW

Number 188-90

To amend By-law 193-83 (the regulation of traffic) for the placement of parking restrictions on Pennington Place, Hinchley Wood Grove, George Street North and Hansen Road North

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 193-83, as amended, is hereby further amended:

(1) by deleting from the specified columns of Schedule I thereto the following items:

NO PARKING ON SPECIFIED HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
George Street North & South	West	A point 25 metres south of Nelson Street West and a point 41 metres south of Queen Street West	Anytime
George Street South	West	A point 41 metres south of Queen Street West and Wellington Street West	6 a.m. - 6 p.m.

(2) by adding to the specified columns of Schedule I thereto the following items:

NO PARKING ON SPECIFIED HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
George Street North & South	West	A point 25 metres south of Nelson Street West and a point 49 metres south of Queen Street West	Anytime
George Street South	West	A point 139 metres south of Queen Street West and Wellington Street West	Anytime
Hinchley Wood Grove	West	Bovaird Drive and Centre Street North	Anytime

Hansen Road North	South/ East	A point 59 metres north of Abell Drive and a point 84 metres north of Abell Drive	Anytime
Pennington Place	Both	North Park Drive to the westerly limit of the road	Saturdays and Sundays from 9:00 a.m. - 8:00 p.m. during June July and August

(3) by adding to the specified columns of Schedule III thereto the following items:

George Street South	West	A point 49 metres south of Queen Street West and a point 139 metres south of Queen Street West	6:00 a.m.- 6:00 p.m.	1 hour
