Number 188-2008

To amend by-law 138-2008 to authorize the expropriation of certain lands for the purpose of road widenings (Chinguacousy Road)


Section 6 of the Municipal Act 2001 authorizes the Council of every corporation to pass a by-law for acquiring or expropriating any land required for the purposes of the corporation. The Council of the Corporation of the City of Brampton has determined that it is necessary and in the interest of The Corporation of the City of Brampton to acquire lands and interest in lands, herein described for road widening purposes.

NOW THEREFORE the Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:**


1. The expropriation of the lands and interest in the City of Brampton described in Schedule "A" to this by-law for the purpose of a road widening of Chinguacousy Road and associated relocation of utilities, is hereby authorized.
2. Schedule "A" to By-law 138-2008 is hereby deleted and replaced with Schedule "A" to this By-law.
3. The Mayor and City Clerk are hereby authorized to execute on behalf of The Corporation of the City of Brampton as expropriating authority all notices, applications, advertisements and other documents required by the Expropriations Act, R.S.O. 1990, c.E.26, as amended, in order to effect the expropriation of the said lands.

**The temporary drainage easement is to allow access to the subject lands with workers, material and equipment for the purpose of constructing, shaping and maintaining drainage works until such time as the adjacent subdivision has been developed.
