To authorize the permanent closure of part of the Road Allowance between Concesssions 3 and 4 W.H.S. known as Creditview Road and surplus declaration of lands

WHEREAS it is deemed expedient in the interest of The Corporation of the City of Brampton that part of Creditview Road legally described as part of the Road Allowance between Concessions 3 and 4 WHS designated as Parts 9, 31 to 42 inclusive, 45 to 47 inclusive, 53 to 59 inclusive and 61 to 66, inclusive on draft reference plan prepared by S.J. Balban, OLS Ref. No. 03-28-827-06-F dated August 17, 2006 ("Closed Road Parts") be permanently closed;

AND WHEREAS it is deemed expedient in the interest of The Corporation of the City of Brampton that the Closed Road Parts and part of Lot 10, Concession 4 WHS designated as Parts 2, 11 to 30 inclusive, 43, 44, 51 and 52 on draft reference plan prepared by S.J. Balban, OLS Ref. No. 03-28-827-06-F dated August 17, 2006 be declared surplus;

**AND WHEREAS** pursuant to By-laws 393-2002 and 273-2005 notice of the intention to pass this by-law has been published in the Brampton Guardian newspaper a minimum of five and not more than twenty-one days prior to the Council meeting at which this by-law was considered;

AND WHEREAS the Council for the said Corporation has heard in person or by counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this by-law and who applied to be heard;

**NOW THEREFORE** the Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS**:

- 1. Part of the Road Allowance between Concessions 3 and 4 WHS designated as Parts 9, 31 to 42 inclusive, 45 to 47 inclusive, 53 to 59 inclusive and 61 to 66, inclusive on draft reference plan prepared by S.J. Balban, OLS Ref. No. 03-28-827-06-F dated August 17, 2006 ("Closed Road Parts") are hereby permanently closed.
- 2. Subject to the registration of the by-law closing the Closed Road Parts, the Closed Road Parts and part of Lot 10, Concession 4 WHS designated as Parts 2, 11 to 30 inclusive, 43, 44, 51 and 52 on draft reference plan prepared by S.J. Balban, OLS Ref. No. 03-28-827-06-F dated August 17, 2006 are declared surplus.
- 3. The Mayor and Clerk are hereby authorized to execute all documents and instruments approved by the City Solicitor as may be necessary to give effect to this by-law.
