WHEREAS the Brampton Hydro Electric Commission desires to undertake certain additions to their distribution system as set out in Schedule "A" hereto attached.

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. That the Hydro Electric Commission of the City of Brampton shall undertake certain additions to its distribution system as set out in Schedule "A" hereto attached at a total estimated cost of \$1,925,000.00.
- 2. That the Mayor and the Treasurer are hereby authorized in the name of and on behalf of The Corporation to borrow from time to time by way of promissory note from the Royal Bank of Canada, 1 Main Street North, Brampton a sum or not the exceeding in aggregate \$1,925.000.00 for the aforementioned purpose and to give on behalf of the Corporation to the Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 14th day of September, 1981.
