To Establish a Scale of Costs under the Municipal Tax Sales Act, (R.S.O. 1990) and to repeal By-Law 105-85

WHEREAS Section 15 of the <u>Municipal Tax Sales Act</u>, (<u>R.S.O. 1990</u>), permits the council of a municipality to fix a scale of costs to be charged as reasonable costs of proceedings under this Act:

AND WHEREAS the scale of costs is to be determined by a bylaw of the council of the municipality.

NOW THEREFORE, the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- That the costs to be charged for the proceedings under the <u>Municipal Tax Sales Act</u>, listed in Column One of Schedule A to this by-law, be those set out in Column Two of Schedule A to this by-law.
