1. By-law 193-83, as amended, is hereby further amended:

(1) by adding to the specified columns of Schedule XII
thereto the following item:

SCHOOL BUS LOADING ZONES

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 SCHOOL OR INSTITUTION
Gretna Drive	South	A point 36 metres east of Kimbark Drive and a point 68 metres east of Kimbark Drive	Northwood Public School

This by-law shall not come into force until approved by the council of The Regional Municipality of Peel.


