# BY-LAW

Number 199-2009

A By-law to Amend By-law 196-2009  
Appointing Officers to Enforce  
Parking on Private Property

THE COUNCIL OF THE CORPORATION OF THE CITY OF  
BRAMPTON ENACTS AS FOLLOWS:


1. By-law 196-2009 is hereby amended as follows:  
  
Replace Schedule A to By-law 196-2009 with the attached  
Schedule I to this by-law.
  
2. A municipal law enforcement officer appointed by this By-law may  
enter on land at any reasonable time for the purpose of carrying out an  
inspection to determine whether or not the following are being complied with:
  - (a) a by-law of The Corporation of the City of Brampton passed under the  
*Municipal Act, 2001*, as amended;
  - (b) a direction or order of The Corporation of the City of Brampton made  
under the *Municipal Act, 2001*, as amended, or made under a by-law;
  - (c) a condition of a license issued under a by-law; or
  - (d) an order made under section 431 of the *Municipal Act, 2001*, as  
amended.
  
3. A municipal law enforcement officer exercising a power of entry may:
  - (a) require production for inspection of documents or things relevant to the  
inspection;
  - (b) inspect and remove documents or things relevant to the inspection for  
the purpose of making copies or extracts;
  - (c) require information from any person concerning a matter related to the  
inspection; and
  - (d) alone or in conjunction with a person possessing special or expert  
knowledge, make examinations or take tests, samples or photographs  
necessary for the purposes of the inspection.


4. Subject to section 5, this By-law prevails to the extent of any conflict between this By-law and any other by-law of The Corporation of the City of Brampton.

5. This by-law does not restrict any rights conferred by the *Municipal Act, 2001*, as amended, or any other Act or regulation, respecting entry to land.

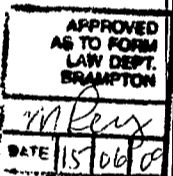
