A By-law to amend	By-law Number 825 of
the former Townsh	ip of Toronto Gore as
it pertains to pa	rt of Lot 16, Concession
8, Northern Divis	ion, in the former Township
of Toronto Gore,	now in the City of Brampton

The Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. Schedule A of By-law 825, as amended, being the Restricted Area By-law of the former Township of Toronto Gore is hereby further amended by changing the zoning designation of the lands shown outlined on Schedule A attached to this by-law from AGRICULTURAL (A) to ESTATE RESIDENTIAL (ER), ESTATE RESIDENTIAL HOLDING CATEGORY SECTION 56 (ER(H) SECTION 56), and FLOODPLAIN (F), such lands being part of Lot 16, Concession 8, Northern Division, of the former Township of Toronto Gore, now in the City of Brampton.
- Schedule A of this by-law is hereby attached to By-law
 825 as part of Schedule A, and forms part of By-law 825.
- 3. By-law 825 is further amended by adding thereto the following section:
 - "56.1 The lands designated as ER(H) SECTION 56 on Schedule A hereto attached shall be used for the purposes permitted in an Estate Residential Zone only after the holding designation (H) has been removed by amendment to this by-law.
 - An application to remove the holding designation (H) shall not be considered until these lands form a parcel in conjunction with adjacent lands resulting in compliance with the provisions of the Estate Residential Zone with respect to minimum lot area. "

4. This by-law shall not come into force without the approval of the Ontario Municipal Board.




