BY-LAW

Number 201-78

To Amend By-law 861, as amended and renumbered by By-law 877, and as further amended, of the former Township of Chinguacousy.

The Council of the Corporation of the City of Brampton
ENACTS as follows:

1. Schedule "A" of By-law 861 as amended and renumbered by By-law 877, and as further amended is amended by changing the designation of the land shown outlined on Schedule "A" attached hereto from Industrial General (M2) to Industrial Select 5 Special (M5S).
2. Schedule "A" attached to this By-law is hereby attached to By-law 861 as Map 502 and forms part of By-law 861.
3. By-law 861 is amended by adding thereto, the following section:


"202. (1) Notwithstanding the permitted use of business offices, offices for doctors and dentists and pharmacy operations are not permitted on the lands shown outlined on Map 502.


(2) The maximum gross floor space of any building on the lands shown outlined on Map 502 shall not exceed twenty-seven hundred and ninety (2790) square metres (30,031 square feet)."

4.0 This By-law shall not come into force until approved by the Ontario Municipal Board.

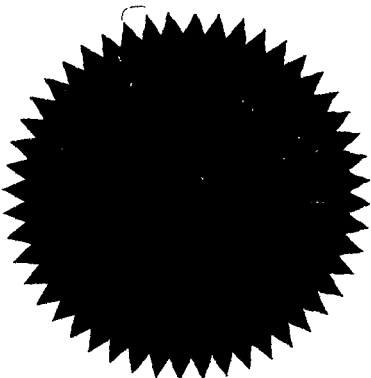
