BY-LAW

Number _____ 203-94

To authorize the sale of part of the service road on Registered Plan 541

WHEREAS by By-law 259-87, the Council of The Corporation of the City of Brampton stopped up and closed and authorized the lease of the part of the service road according to Registered Plan 541 designated as Part 2 on Reference Plan 43R-14932;

AND WHEREAS the Council of The Corporation of the City of Brampton deems it expedient to authorize the sale of the said part of the service road;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four consecutive weeks in The Brampton Guardian, a newspaper published in the City of Brampton;

AND WHEREAS the Council for the said corporation has heard in person or by counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this by-law and who apply to be heard;

NOW THEREFORE The Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS**:

- 1. The sale of the part of the service road according to Registered Plan 541 designated as Part 2 on Reference Plan 43R-14932 (which was stopped up and closed by By-law 259-87 passed in Open Council November 9, 1987) is hereby authorized.
- 2. The intended purchaser and the purchase price to be charged shall be determined by a subsequent by-law of Council.
- 3. The affidavit of Leonard J. Mikulich attached as Schedule A to this by-law forms part of this bylaw.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 11th day of October, 1994.
