To amend By-law 93-93, RATE OF SPEED

The council of the Corporation of the City of Brampton hereby ${\tt ENACTS}$ as follows:

- 1. By-law 93-93, as amended, is hereby further amended as follows:
 - (1) by deleting from Schedule X thereto the following items:
