BY-LAW

To amend By-law 93-93,

DESIGNATED TURNING LANES, NO PARKING, FIRE ROUTES

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

- By-law 93-93, as amended, is hereby further amended as follows:
 - (1) by deleting from Schedule VI thereto the following items:
