A by-law to amend By-law 93-93

THE COUNCIL of the Corporation of the City of Brampton ENACTS as follows;

- 1. By-law 93-93, as amended, is hereby further amended by renumbering Section 22 as Section 22(1) and by adding Section 22(2) as follows:
  - "22(2) Every driver or operator of a vehicle shall obey the instructions or directions indicated on any sign erected in accordance with the schedules of this by-law".
- 2. By adding the following as Subsection 1(c) to Section 46:
  - "46(1)(c) If a parking space has been designated by lines painted on the surface of the parking area on private property, no person shall park any vehicle in such a manner that is not wholly within the area designated as a parking lot space".
- 3. By adding in Part VI, Section 42 by adding after the word "sidewalk", "in a manner that would obstruct the sidewalk".
- 4. By adding in Part VI, Section 55 the words "No person shall" before the first word "Where".
