To amend Bv-law 193-83 (the regulation of traffic) for the placement of NO PARKING ON SPECIFIED HIGHWAYS, THROUGH HIGHWAYS AND RATE OF SPEED - KILOMETRES/HOUR

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

- By-law 193-83, as amended, is hereby further amended:
 - (1) by deleting from the specified columns of Schedule I thereto the following items:
