BY-LAW

Number 207-76

A By-law to authorize a capital expenditure in the amount of \$764,000.00 for the reconstruction of certain streets.


WHEREAS the Council of the Corporation of the City of Brampton desires to undertake the reconstruction of certain streets;

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

1. That the Council of the Corporation of the City of Brampton shall undertake the reconstruction of those streets set out in Schedule "A" attached hereto, at a total estimated cost of \$764,000.00.
2. That the Mayor and the Treasurer are hereby authorized in the name of and on behalf of the Corporation to borrow from time to time by way of promissory note from the Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$764,000.00 for the aforementioned purpose and to give on behalf of the Corporation to the Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 12th day of October, 1976.

SCHEDULE "A"

<u>PROJECT</u>	<u>ESTIMATED COST</u>
1. Reconstruction of Ashwood Crescent for its entire length including storm sewers, granular base, curb and gutter, asphalt paving, boulevard sodding and related work approximately 1,850 lineal feet.	\$145,000.00
2. Reconstruction of Alexandria Crescent for its entire length including storm sewers, granular base, curb and gutter, asphalt paving, boulevard sodding and related work - approximately 1,650 lineal feet.	\$130,000.00
3. Reconstruction of Alderbury Crescent for its entire length including storm sewers, granular base, curb and gutter, asphalt paving, boulevard sodding and related work - approximately 1,700 lineal feet.	\$135,000.00
4. Reconstruction of Meadowland Drive from Clarence Street to Eldomar Avenue including storm sewers, granular base, curb and gutter, asphalt paving, boulevard sodding and related work - approximately 1,300 lineal feet.	\$152,000.00
5. Reconstruction of Woodward Avenue from Beech Street to Kennedy Road including storm sewers, granular base, curb and gutter, asphalt paving, boulevard sodding and related work - approximately 1,200 lineal feet.	\$117,000.00
6. Reconstruction of Elliott Street from Harold Street to Frederick Street including granular base, curb and gutter, asphalt paving, boulevard sodding and related work - approximately 900 lineal feet.	\$85,000.00
