To amend By-law 200-82  
(former Town of Brampton  
Comprehensive Zoning By-law)

The council of the Corporation of the City of Brampton  
ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:
  - (1) by deleting therefrom, section 10.3(b)(8) and substituting therefor, the following section 10.3(b)(8):
 

"(8) the maximum height of an accessory building shall not exceed 3.0 metres; and,"
  - (2) by deleting therefrom, the words "operated by a public authority" in sections 32.1.1(b)(3), 33.1.1(b)(2) and 34.1.1(b)(2).

READ a FIRST, SECOND and THIRD time and PASSED in OPEN COUNCIL this 27th day of September 1993.
