- Amendment Number OP 93-<u>102</u> to the Official Plan of the City of Brampton Planning Area is hereby adopted and made part of this bylaw.
- The Clerk is hereby authorized and directed to make application to the Regional Muncipality of Peel for approval of Amendment Number OP93-102 to the Official Plan of the City of Brampton Planning Area.

AMENDMENT NUMBER OP 93- 102 TO THE OFFICIAL PLAN OF THE CITY OF BRAMPTON PLANNING AREA

1.0 Purpose:

The purpose of this amendment is to change the land use designation of the lands shown outlined on Schedule A to the amendment to permit the development of the subject lands support the development of the subject lands for commercial purposes and to provide specific policies for the development of the subject lands.

2.0 Location

The lands subject to this amendment are located at the north-east corner of Chrysler Drive and Highway Number 7 within Lot 6, Concession 6, E.H.S., in the City of Brampton.

- 3.0 Amendment and Policies Relative Thereto:
- 3.1 The document known as the Official Plan of the City of Brampton Planning Area is hereby amended:
 - (1) by adding to the list of amendments pertaining to Secondary Plan Area Number 37: Airport Road/Highway 7 Business Centre as set out in Part II: Secondary Plans, Amendment Number OP93
 102 .
- The portions of the document known as the 1984 Official Plan of the City of Brampton Planning Area which remain in force, as they relate to the Airport Road/Highway 7 Business Centre Secondary Plan (being Part IV, Chapter 37 of Part IV- Secondary Plan, as amended) are hereby further amended:
 - (1) by adding to the legend of Schedule SP 37(A), the designation of "Special Policy Area No. 7", as shown on Schedule A to this amendment;
 - (2) by adding to Schedule SP 37(A), the boundary of "Special Policy Area No.7", as shown on Schedule A to this amendment;
 - (3) by changing on Schedule SP 37 (A), the land use designation of the lands within the boundary of "Special Policy Area No.7" as shown on Schedule A to the amendment from "BUSINESS" to "HIGHWAY AND SERVICE COMMERCIAL"; and,
 - (4) by deleting from Schedule SP 37 (A) and Schedule SP 37 (B) the "PROPOSED LOCAL ROAD", as shown on Schedules A and B to this amendment.
 - (5) by adding after section 3.8.7 the following:
 - "3.8.8 Special Policy Area No. 7 at the north-east corner of Chrysler Drive and Highway Number 7 applies to those lands designated.


 HIGHWAY AND SERVICE COMMERCIAL on Schedule SP 37 (A). In addition to the uses permitted in the HIGHWAY AND SERVICE COMMERCIAL designation, these lands may also be developed for the uses in the BUSINESS designation in accordance with policies contained in Section 3.2. However, these lands will not be used

for supermarket or department store purposes, or for more than two dining room restaurants. So as not to significantly detract from the role of the Central Area, a maximum of 3% of the total gross commercial floor area on the site shall comprise retail establishments less than 465 square metres."


