# BY-LAW

Number 208-2014

To exempt the property municipally known as  
18 Tortoise Court from Interim Control By-Law 35-2013

The Council of The Corporation of the City of Brampton, in accordance with the provisions of the *Planning Act*, R.S.O. 1990, c.P. 13, hereby ENACTS as follows:


1. By-Law 35-2013, as amended, is hereby amended as follows:
  - 1.1 Section 1 is amended by adding after the words "Except as provided for in Section 1.1, Section 1.2, Section 1.3, Section 1.4, Section 1.5, Section 1.6, Section 1.7, Section 1.8, Section 1.9, Section 1.10, Section 1.11, Section 1.12, Section 1.13, Section 1.14, Section 1.15, Section 1.16, Section 1.17, Section 1.18, Section 1.19, Section 1.20, Section 1.21, Section 1.22, Section 1.23, Section 1.24, Section 1.25, Section 1.26, Section 1.27 and Section 1.28" the following: "Section 1.29"
  - 1.2 The following is added as Section 1.29:

"1.29 On lands described as Concession 7 ND, Part of Lot 7 and referenced as the "Lands Subject to Specific Exemption From Interim Control By-Law 35-2013, as amended by By-Law 208-2014 " and as shown on Schedule A to this by-law as 18 Tortoise Court, there shall be permitted an addition to the principle dwelling not exceeding 3960 square feet."
2. Schedule A attached to this by-law is added as Schedule EE to Interim Control By-Law 35-2013, as amended.

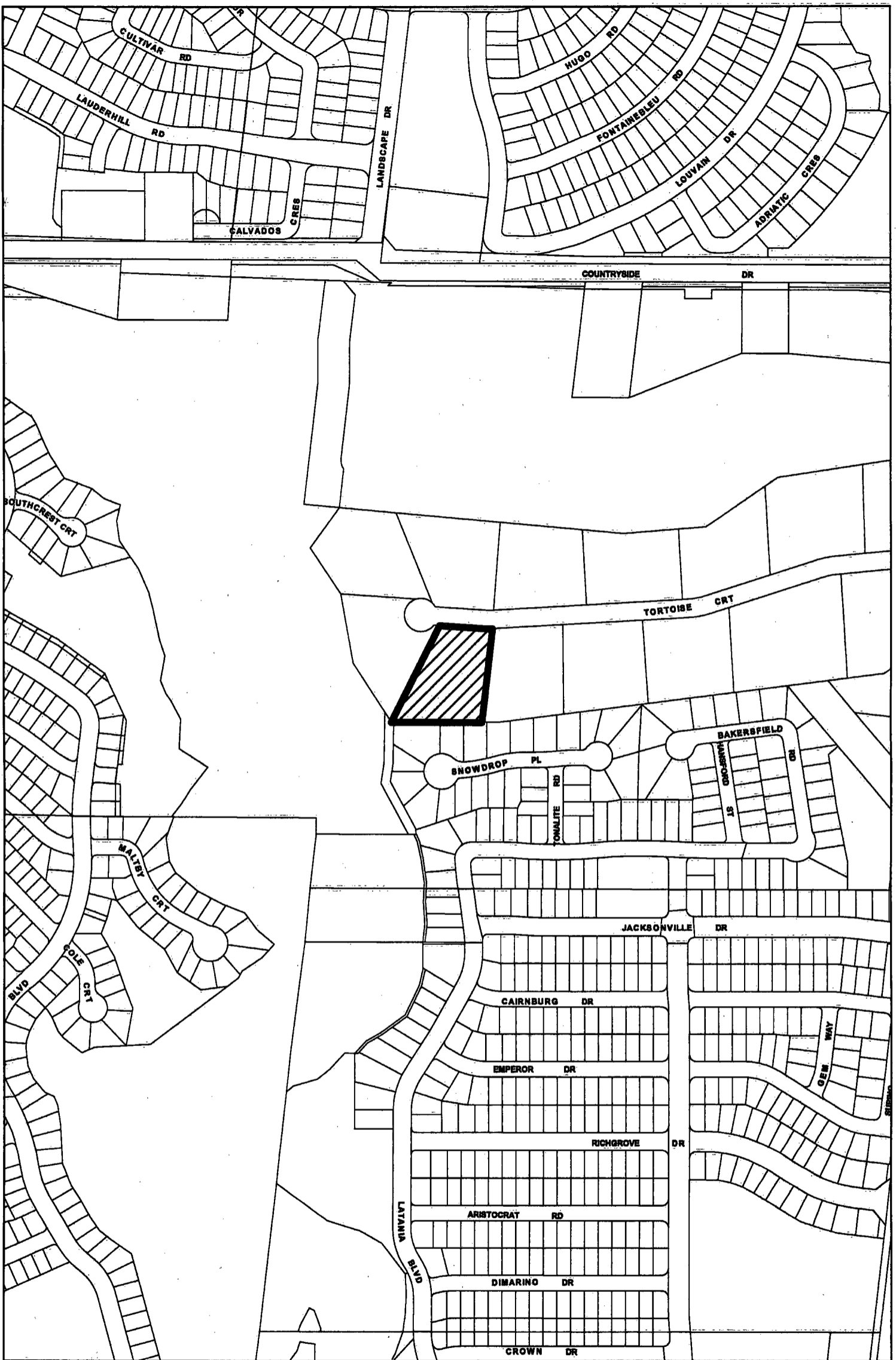
