BY-LAW

Number 210 - 2013

To amend the Schedules of Traffic By-law 93-93 relating to RATE OF SPEED (Schedule X), NO PARKING (Schedule XIV), DESIGNATED BICYCLE LANES (Schedule XXX), HEAVY TRUCKS (Schedule XI) and FIRE ROUTES (Schedule XXII)

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93, as amended, is further amended by DELETING the following items from Schedule X:

RATE OF SPEED

| COLUMN 1 | COLUMN 2 | COLUMN 3 | COLUMN 4 |

| HIGHWAY | RATE OF SPEED | BETWEEN | TIMES OF DAY |
| Creditview | 60 | Queen Street West to James Potter Road | Anytime |

NO PARKING

| Fletchers Creek Boulevard | West | Legacy Lane and a point 44 metres south of Binder Twine Trail | Anytime |

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XXX:

DESIGNATED BICYCLE LANES

| Bonnie Braes Drive | Creditview Road and Chinguacousy Road | Adjacent to curb lane or parking lane | Both |

HEAVY TRUCKS

| Countryside Drive | Highway 50 and The Gore Road | Anytime |
| Countryside Drive | McVean Drive and Bramalea Road | Anytime |

5. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XXII:
