A By-law to authorize a capital expenditure in the amount of \$50,000.00 for the construction of certain sidewalks.

WHEREAS the Council of The Corporation of the City of Brampton desires to undertake the construction of certain sidewalks.


NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

 That the Council of The Corporation of the City of Brampton shall undertake the construction of those sidewalks set out in Schedule "A" attached hereto, at a total estimated cost of \$50,000.00.

2. That the Mayor and the Treasurer are hereby authorized in the name of and on behalf of the Corporation to borrow from time to time by way of promissory note from The Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$50,000.00 for the aforementioned purpose and to give on behalf of the Corporation to The Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

SCHEDULE "A" TO

BY-LAW NO. 213-77

- <u>KENNEDY ROAD</u> (east side) from Rambler Drive (extension) to 760 feet northerly, a distance of approximately 760 feet.
- 2. <u>BRAMALEA ROAD</u> (east side) from Balmoral Drive to Clark Boulevard, a distance of approximately 2,250 feet.
- 3. <u>GLENRIDGE ROAD</u> (east side) from Williams Parkway to <u>Glenforest Road</u>, a distance of approximately 750 feet.
- 4. GORE ROAD (9th line east) (west side) from No. 10 Sideroad to Fitzpatrick Drive, a distance of approximately 1,400 feet.
- 5. GRAYMAR DRIVE (east side) from Greenmount Road to Williams Parkway, a distance of approximately 750 feet.
- DIXIE ROAD (east side) from Crescent Hill (south leg) to North limit of Lot 7, a distance of approximately 800 feet.
- 7. <u>DIXIE ROAD</u> (west side) from Balmoral Drive to 500 feet northerly, a distance of approximately 500 feet.
- VODDEN STREET (north side) from Rutherford Road to 1,000 feet easterly, a distance of approximately 1,000 feet.
- 9. <u>PEDESTRIAN WALKWAY</u> from Elgin Drive to Parkend Avenue, a distance of 200 feet.
