plans of parts thereof as are designated in the by-law;

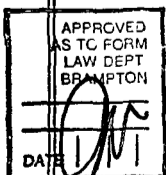
NOW THEREFORE the Council of The Corporation of the City of

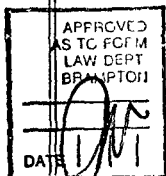

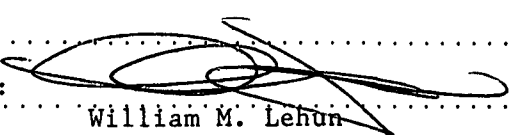
