To prevent the application of part lot control to part of Registered Plan 43M-1043

WHEREAS subsection 50(5) of the <u>Planning Act</u>, R.S.O. 1990 c.P.13, has imposed part lot control on all lands within registered plan within the City;

AND WHEREAS, pursuant to subsection 50(7) of the <u>Planning Act</u>, the council of a municipality may by by-law provide that part lot control does not apply to lands within such registered plans of parts thereof as are designated in the by-law;

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby ENACTS as follows:

1. Subsection 5 of section 50 of the <u>Planning Act</u>, does not apply to the following lands:

> City of Brampton, Regional Municipality of Peel, being composed of Lots 3, 4, 9 to 14, 16 and 19, all inclusive, on Plan 43M-1043.

This by-law shall come into force upon approval thereof by the Regional Municipality of Peel.
