To accept and assume lands as part of a public highway in the City of Brampton.


WHEREAS it is deemed expedient to accept and assume lands in conveyance from various parties as parts of public highways;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

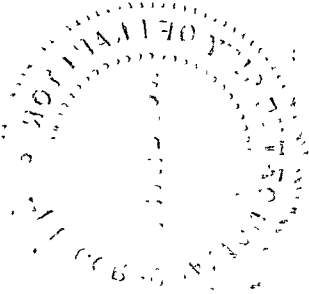

(Part of Vodden Street).

SECONDLY: 435096

All and Singular that certain parcel or tract of land and premises situate lying and being in the City of Brampton in the Regional Municipality of Peel (formerly in the Township of Chinguacousy in the County of Peel) containing by admeasurement 0.096 acres, more or less, being composed of part of Lots 3 and 4 as shown on Plan Number 311 (Chinguacousy) registered in the Registry Office for the Registry Division of Peel (No. 43), the boundaries of which said parcel may more particularly be described as follows, and

PREMISING that the road allowance between Concessions Four and Five West of Hurontario Street through Lot Five in the said City of Brampton, has a governing bearing of North 44 degrees 18 minutes 00 seconds West and relating all bearings quoted herein thereto;

COMMENCING at a standard iron bar planted marking the most Westerly angle of the said Lot Four;

THENCE South 83 degrees 56 minutes 10 seconds East 87.75 feet to a standard iron bar planted;
