To Amend By-law Number 33-79 being a by-law for the Regulation of Traffic

WHEREAS the Council of the Corporation of the City of Brampton deems it expedient and advisable to amend By-law Number 33-79, being a by-law for the regulation of traffic.

NOW THEREFORE the Council of the Corporation of the City of Brampton hereby enacts as follows:

1. Part 5 (6) of By-law 33-79, as amended, is hereby declared not to apply to the part set out in Column 2 below of the highways set out in Column 1 below, from September 21, 1981 until October 12, 1981 or until construction affecting the said parts of the said highways is completed, whichever comes first.
