WHEREAS paragraph 45 of section 207 of the <u>Municipal Act</u> (R.S.O. 1990, c. M.45, as amended) provides that a municipality may pass by-laws for appointing such officers and servants as may be necessary for carrying into effect the provisions of any by-law of the Council, and for prescribing their duties;

AND WHEREAS section 15 of the <u>Police Services Act</u> (R.S.O. 1990, c. P.15, as amended) authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality;

AND WHEREAS it is necessary to appoint additional officers to enforce the provisions of By-law 206-79 (which regulates parking on private and municipal property) in respect of certain private properties;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- 1. The individuals named in Column 1 of Schedule A to this By-law are hereby appointed as By-law Enforcement Officers for the purpose of By-law 206-79, but only in respect of the corresponding properties named and identified in Column 2 of Schedule A to this By-law. Where no municipal address is set out in Column 2 the said officers may enforce By-law 206-79 in respect of all the properties located upon the streets listed in Column 2.
- In enforcing By-law 206-79, a By-law Enforcement Officer appointed under this By-law may only take the actions authorized by Section 4 of By-law 206-79.
- 3. By-law 101-88 is hereby repealed.
