# BY-LAW

Number 214-2000

To amend By-law 93-93,  
**HEAVY TRUCKS, NO PARKING  
AND RATE OF SPEED**

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule XI thereto the following item:

## HEAVY TRUCKS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN	COLUMN 3 TIMES OR DAYS
Gorewood Drive	Steeles Avenue and the north limit of Gorewood Drive	Anytime

(2) by deleting from Schedule XIV thereto the following item:

## NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Notre Dame Avenue	North	A point 30 metres west of Solway Avenue to a point 30 metres east of Solway Avenue	Anytime

(3) by adding to Schedule XIV thereto the following item:

**NO PARKING**

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Notre Dame Avenue	North	A point 45 metres west of Solway Avenue to a point 30 metres east of Solway Avenue	Anytime

(4) by deleting from Schedule X thereto the following item:

**RATE OF SPEED**

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
North Park Drive	40	Jefferson Drive and Jaffa Drive	Anytime

(5) by adding to Schedule X thereto the following items:

**RATE OF SPEED**

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Lockwood Road	40	Sterritt Drive and Queen Street West	Anytime
North Park Drive	40	Jefferson Road and Jaffa Drive	Anytime

2. Section 1, subsections (1), (4) AND (5) of this by-law shall not come into force until approved by the council of the Regional Municipality of Peel.


