WHEREAS a by-law, Number 59-79 of the Grantor passed the 12th day of March, 1979 and registered in the Registry Office for the Registry Division of Peel (No. 43) on the 23rd day of April, 1979 as Instrument No. 512098 stopped up and closed the herein described road allowance and authorized its sale to the Grantee.

WITNESSETH that in consideration of other good and valuable consideration and the sum of ONE ------DOLLAR -----DOLLAR of lawful money of Canada now paid by the said Grantee to the said Grantor (the receipt whereof is hereby by it acknowledged), the said Grantor does grant unto the said Grantee in fee simple.

ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the City of Brampton in The Regional Municipality of Peel (formerly in the Township of Chinguacousy, in the County of Peel), and being composed of that part of the road allowance between Lots 10 and 11, Concession 5, East of Hurontario Street, designated as Parts 1, 4 and 5, on Reference Plan 43R-6176.
