# **BY-LAW**

Number	218-91	

To Amend By-law 200-82, as amended, (Part of Lot 6, Concession 1, W.H.S. in the Geographic Township of Chinguacousy)

The Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 200-82, as amended, and as specifically amended by By-law 189-91, is hereby further amended:
  - (1) by changing, on Sheet 5 of Schedule 'A' thereto, the zoning designation of the lands shown outlined on Schedule 'A' to this by-law from RESIDENTIAL SINGLE-FAMILY C (R1C) to OPEN SPACE (OS), such lands being part of Lot 6, Concession 1, West of Hurontario Street, in the geographic Township of Chinguacousy.

READ a FIRST, SECOND and THIRD TIME and PASSED in OPEN COUNCIL this 16th day of October 1991.



# PART BLOCK C REG PLAN 307




### Legend:
