



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 218-2012

To amend By-law 270-2004, as amended

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 270-2004, as amended, is hereby further amended:

(1) by changing Schedule A thereto, the zoning designation of the lands as shown outlined on Schedule A to this by-law:

(2) by adding thereto the following section:

“2298 The lands designated M4 – 2298 on Schedule A to this by-law:

2298.1 Shall only be used for the following purposes:

- (1) The uses permitted in the M4-1569 zone
- (2) A gas bar or service station (truck fueling station) and associated office
- (3) Only in conjunction with a gas bar or service station, a retail establishment having no outside storage

2298.2 A gas bar or service station (truck fueling station) and associated office and retail use shall be subject to the following requirements and restrictions:

- (1) Maximum Building Height: 2 storeys for an office building
- (2) Minimum Setback to Delta Park Blvd: 5 metres
- (3) Minimum Setback to Nevets Road: 5 metres
- (4) Minimum number of Parking Spaces: 24
- (5) Minimum Landscaped Open Space: except at approved driveway locations, a minimum 3 metre wide landscape strip shall be provided abutting all property lines
- (6) Minimum 6 fueling bays
- (7) No outside storage shall be permitted

2298.3 Uses permitted in the M4-1569 zone shall be subject to the restrictions and requirements of the M4-1569 zone

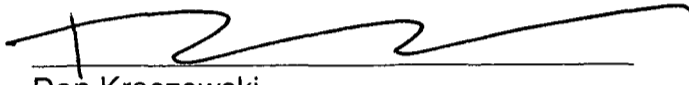

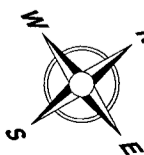

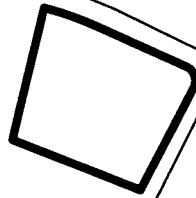
