



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 220-82

To amend By-law 200-82, as amended.

The Council of The Corporation of The City of Brampton hereby ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:

- (1) by changing the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE-FAMILY B ZONE - R1B (R1B) to RESIDENTIAL SINGLE-FAMILY B ZONE - R1B - SECTION 190 (R1B-SECTION 190), such lands being part of Lot 5, Concession 1, West of Hurontario Street, being 49 Wellington Street West, of the former Town of Brampton, now in the City of Brampton.
- (2) by deleting Sheet 23 of Schedule A thereto, and substituting therefor Schedule B hereto attached, and
- (3) by adding thereto the following section:

"190 The lands designated as R1B - SECTION 190 on Schedule A to this bylaw


190.1 shall only be used for:

- (a) a single-family detached dwelling, or
- (b) a day care centre, but only as a purpose accessory to a single-family detached dwelling.

190.2 shall be subject to the requirements and restrictions relating to an R1B Zone."


