# AMENDMENT NUMBER OP93-21 TO THE OFFICIAL PLAN OF THE CITY OF BRAMPTON PLANNING AREA

#### 1.0 Purpose:

The purpose of this amendment is to add to the list of amendments pertaining to Secondary Plan Area 28: Sandringham-Wellington,

Amendment Number 252 to the document known as the 1984 Official Plan.

#### 2.0 <u>Location</u>:

The specific lands subject to this amendment within Secondary Plan Area 28 consist of 4.3 ha (10.7 acres) more or less encompassed within the current Community Park and Neighbourhood Park designations abutting the TransCanada Pipeline between Torbram Road and Bramalea Road in the Sandringham-Wellington Secondary Plan area.

#### 3.0 Amendment and Policies Relative Thereto

The document known as the Official Plan of the City of Brampton Planning Area is hereby amended:

(1) by adding to the list of amendments pertaining to Secondary
Plan Area 28: Sandringham-Wellington, set out in Part II:

### BACKGROUND MATERIAL TO AMENDMENT NUMBER OP93- 21
