**BY-LAW**

To stop up and close and authorize the sale of the lane between Lots 18 and 19, Plan 521 and the lane between Lots 2 and 3, Plan 569

WHEREAS Section 57(1) of the <u>Surveys Act</u>, (R.S.O. 1980, c. 493, as amended), deems every lane shown on a plan of subdivision to be a public lane;

AND WHEREAS the lane between Lots 18 and 19, Registered Plan 521, and the lane between Lots 2 and 3, Registered Plan 569 are not required for municipal purposes;

AND WHEREAS notice of the intention to pass this by-law was published once a week for four consecutive weeks in the Brampton Times, a newspaper published in the City of Brampton;

AND WHEREAS the said Corporation has given notice to The Regional Municipality of Peel, pursuant to Section 49 of the <u>Regional Municipality of Peel Act</u> (R.S.O. 1980, c.440, as amended) and The Regional Municipality of Peel has indicated that it does not object to such stopping up;

AND WHEREAS the Council for the said Corporation has heard in person or by counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this by-law and who applied to be heard;

AND WHEREAS John Tedder and Sylvia Tedder of 37 Cornwall Road were given the opportunity to purchase the part of the lane on Registered Plan 521 which abuts their lands and did not reply to the letters sent by the City Property Manager.

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1.

The lane between Lots 18 and 19, Registered Plan 521, is hereby stopped up and closed. The sale of the said lane to Robert Haw and Ann Haw is hereby authorized subject to the reservation or conveyance of easements for existing public utilities. The purchase price shall be \$500.00 plus the legal, survey and advertising costs associated with the closure.

2. The lane between Lots 2 and 3, Registered Plan 569 is hereby stopped up and closed. The sale of the northerly half of the said lane to Three Phase Electric Limited and Strovolos Enterprises Inc. is hereby authorized, subject to the reservation or conveyance of easements for existing public utilities. The purchase price shall be \$250.00 plus the legal, survey and advertising costs associated with the closure. The sale of the southerly half of the said lane to Eldomar Investments Limited for \$1.00 plus the legal, survey and advertising costs associated with the closure is hereby authorized, subject to the reservation or conveyance of easements required for existing public utilities.

3. The Mayor and Clerk are hereby authorized to execute all documents which are necessary, in the opinion of the City Solicitor, to effect the conveyances.

The affidavit of Leonard J. Mikulich attached as Schedule A forms part of this by-law.

1. I am employed as Clerk and Director of Administration for The Corporation of the City of Brampton and as such, I have knowledge of the facts herein contained.

2. The form of public notice attached as Exhibit 1 to this my affidavit was published in the Brampton Times on the dates listed below:

In accordance with Section 49 of the <u>Regional</u> <u>Municipality of Peel Act</u>, a registered letter was sent from The Corporation of the City of Brampton to The Regional Municipality of Peel advising the Region of the City's intention to stop up and close the lane between Lots 18 and 19, Plan 521 and the lane between Lots 2 and 3, Plan 569. D.R. Billett, Director of Development Control for the Region, to whom the Region delegated approving authority for street closures, indicated to the City of Brampton that The Regional Municipality of Peel had no objection to the said stopping up of the said lanes. A copy of his letter is attached as Exhibit 2 to this my affidavit.

4. The matter of the stopping up, closing and sale of the said lanes came before City Council at its meeting of the 28th day of September, 1987. No persons applied to be heard in respect of this matter.
