AMENDMENT NUMBER OP93-<u>125</u> TO THE OFFICIAL PLAN OF THE CITY OF BRAMPTON PLANNING AREA

1.0 <u>Purpose</u>:

In accordance with the recommendations of a transportation study completed by Marshall Macklin Monaghan dated September 1999, the purpose of this amendment is to adjust the local and collector road network within Secondary Plan Areas 14 (Gore Industrial North), 23 (Gore Industrial) and 37 (Airport Road/Highway Number 7 Business Centre)

2.0 <u>Location</u>:

The lands subject to this amendment are located within the area generally defined as Williams Parkway to the north, Airport Road to the west, Goreway Drive/Humberwest Parkway to the east and Armthrope Road to the south and are described as Part of Lots 4, 5 & 6, Concessions 6 & 7, Northern Division, in the City of Brampton.

3.0 Amendment and Policies Relative Thereto:

- 3.1 The document known as the Official Plan of the City of Brampton Planning Area is hereby amended:
 - (1) by adding or deleting on Schedule "B" Major Road Network Right-of-Way Widths thereto, the collector road right-of-ways as shown on Schedule "A" to this amendment;
 - (2) by adding to the list of amendments pertaining to Secondary Plan Area 14: The Gore Industrial North Secondary Plan as set out in Part II: Secondary Plans, Amendment Number OP93-125;
 - (3) by adding to the list of amendments pertaining to Secondary Plan Area 23: The Gore Industrial Secondary Plan as set out in Part II: Secondary Plans, Amendment Number OP93- 125;
 - (4) by adding to the list of amendments pertaining to Secondary Plan Area 37: The Airport Road/Highway Number 7 Business Centre Secondary Plan as set out in Part II: Secondary Plans, Amendment Number OP93-125;
- 3.2 The portions of the document known as the Consolidated Official Plan of the City of Brampton Planning Area which remain in force, as it relates to the Gore Industrial North Secondary Plan (Secondary Plan Area 14, as amended) is hereby further amended:
 - (1) by realigning on Schedule A to Official Plan Amendment No. 6 thereof, the proposed north-south collector road alignment located just east of Airport Road and extending southward from Williams Parkway as shown on Schedule "B" to this amendment;
- 3.3 The portions of the document known as the Consolidated Official Plan of the City of Brampton Planning Area which remain in force, as it relates to the Gore Industrial Secondary Plan (Secondary Plan Area 23, as amended) is hereby further amended:
 - (1) by deleting the portions of the proposed collector road system in the northeast portion of the Secondary Plan as shown on Schedule A to Official Plan Amendment No. 6 thereof, then adding new portions of proposed collector road alignment to connect with Goreway Drive and with the boundary of Secondary Plan No. 37 (referenced as Official Plan Chapter 37)

- at the north edge of the Secondary Plan, all as shown on Schedule "C" to this amendment;
- 3.4 The portions of the document known as the 1984 Official Plan of the City of Brampton Planning Area, which remain in force, as it relates to The Airport Road/Highway Number 7 Business Centre Secondary Plan (being Chapter 37 of Part IV Secondary Plans, as amended) is hereby further amended:
 - (1) by deleting, revising or adding on Schedules SP37(A) and SP37(B) thereto, the proposed collector road alignments as shown on Schedules "D" and "E" to this amendment;
 - (2) by adding to Section 5.4 <u>Road Access</u> thereof, the following new policy as Section 5.4.4:
 - "5.4.4 To alleviate turning movements at the intersection of Airport Road and Queen Street, the City of Brampton may grant a right-of-way access abutting the rail line under the elevated portion of Regional Road 107 to facilitate private driveway connections between the north and south sides of Regional Road 107."
 - (3) by deleting from Section 5.1 <u>The Road Network</u> thereof, Sections 5.1.4 (iv) 5.1.5 and 5.1.6; and,
 - (4) by renumbering Section 5.1.7 to Section 5.1.5.


