BY-LAW

Number 222-2002.

To amend By-law 93-93,

**THROUGH HIGHWAYS, DESIGNATED TURNING LANES,
RATE OF SPEED, NO PARKING, FIRE ROUTES,**

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule III thereto the following items:

Dovergreen Drive	The north limit of Earlsbridge Boulevard and the north limit of the roadway
Dwellers Road	The east limit of Fletchers Creek Boulevard and the east limit of Vintage Gate (west intersection)
Earl Grey Crescent	The west limit of Edenbrook Hill Drive and the west limit of Bushcroft Trail (south intersection)
Earlsbridge Boulevard	The west limit of Florence Drive and the east limit of the roadway
Edenbrook Hill Drive	The south limit of River Rock Crescent and the north limit of Tideland Drive
Edenbrook Hill Drive	The south limit of Oakmeadow Drive and north limit of Bushcroft Trail
Florence Drive	The north limit of Earlsbridge Boulevard and the south limit of Oakmeadow Drive (south intersection)
Madronnia Gardens	The south limit of Pauline Crescent (north intersection) and the north limit of Bramfield Street
Newark Way	The north limit of River Rock Crescent and the north limit of Avocet Drive
Oakmeadow Drive	The west limit of Florence Drive (north intersection) and the west limit of Edenbrook Hill Drive
Pauline Crescent	The east limit of Madronnia Gardens and the east limit of Carnac Gardens
River Rock Crescent	The west limit of Newark Way/Signet Court and the north limit of Belinda Drive

Rollingwood Drive	The south limit of Ray Lawson Boulevard and the south limit of the roadway
Saddleback Square	The west limit of Butterchurn Road and the south limit of Nostalgia Court
Tideland Drive	The east limit of Carnac Drive and the east limit of Madronnia Gardens
Vintage Gate	The east limit of Fletchers Creek Boulevard and the south limit of Dwellers Road (east intersection)
Yule Court	The east limit of Rollingwood Drive and the east limit of the roadway

(2) by adding to Schedule VI thereto the following items:

(3) by deleting from Schedule X thereto the following item:

Worthington Avenue	40	a point 50 metres south of Springhurst Avenue to a point 40 metres north of Gabrielle Drive	Anytime

(5) by adding to Schedule XIV thereto the following item:

NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Sunforest Drive	Both	Bovaird Drive and a point 10 metres north of Bovaird Drive	Anytime
Sunforest Drive	Both	a point 10 metres north of Bovaird Drive and a point 50 metres north thereof	8:00 a.m. – 5:00 p.m. Monday to Friday




