# **BY-LAW**

227-2001 *Number* 

To amend By-law 93-93, NO PARKING, FIRE ROUTES, THROUGH HIGHWAYS STOP SIGNS, IDLING OF VEHICLES, SCHOOL BUS LOADING ZONES

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:
