# BY-LAW

Number 227-2001

**To amend By-law 93-93,  
NO PARKING, FIRE ROUTES, THROUGH HIGHWAYS  
STOP SIGNS, IDLING OF VEHICLES,  
SCHOOL BUS LOADING ZONES**

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule XIV thereto the following items:

**NO PARKING**

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
North Park Drive	South	Jordan Boulevard and a point 71 metres west of Jordan Boulevard.	Anytime

(2) by adding to Schedule XXII thereto the following items:

**FIRE ROUTES**

COLUMN 1 LOCATION CODE	COLUMN 2 LOCATION
M-68 (F5)	7899 McLaughlin Road (Sheridan College)

(3) by deleting from Schedule III thereto the following items:

**THROUGH HIGHWAYS**

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Leatherhead Court	The north limit of the road and the south limit of the road

(4) by adding to Schedule IV thereto the following items:

**STOP SIGNS**

COLUMN 1 INTERSECTION	COLUMN 2 FACING TRAFFIC
La France Road and Leatherhead Court	southbound Leatherhead Court
La France Road and Leatherhead Court	westbound La France Road
La France Road and Leatherhead Court	northbound Leatherhead Court

(5) by adding to Schedule XXIX thereto the following items:

**IDLING OF VEHICLES**

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN	COLUMN 3 TIMES OR DAYS
Holtby Avenue	west limit of roadway and McLaughlin Road	Anytime

(6) by adding to Schedule VIII thereto the following items:

**SCHOOL BUS LOADING ZONES**

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 SCHOOL OR INSTITUTION
Mary Street	West	a point 270 metres south of Armstrong Street to a point 65 metres south thereof	Cardinal Leger Secondary School

2. Section 1, subsections (3) and (4) of this by-law shall not come into force until approved by the council of the Regional Municipality of Peel.


