AMENDMENT NUMBER OP93- 55
TO THE OFFICIAL PLAN OF THE CITY
OF BRAMPTON PLANNING AREA

1.0 Purpose:

The purpose of this amendment is to add to the list of amendments pertaining to Secondary Plan Area 24: Fletchers Creek South, to include Amendment Number 286 A to the document known as the 1984 Official Plan.

2.0 Location

The lands subject to this amendment are situated on the north side of Ray Lawson Boulevard, approximately 135 metres (442.9 feet) west of the intersection of Ray Lawson Boulevard and Malta Avenue.

3.0 Amendment and Policies Relative Thereto:

The document known as the 1993 Official Plan of the City of Brampton Planning Area is hereby amended:

- (1) by adding to the list of amendments pertaining to Secondary Plan Area 24: Fletchers Creek South, as set out in Part II: Secondary Plans, Amendment Number 286 A to the document known as the 1984 Official Plan.
