To amend By-law 193-83 (the regulation of traffic) for the placement of ALL WAY STOPS
Braidwood Lake Road at Petworth Rd & at Crenshaw Crt

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

- 1. By-law 193-83, as amended, is hereby further amended:
 - (1) by deleting from the specified columns of Schedule VIII thereto the following items:

COLUMN 1 <u>HIGHWAY</u> COLUMN 2 BETWEEN

The south limit of Lakecrest Trail (northerly intersection) and the north limit of Huntley Court/Lakecrest Trail

(2) by adding to the specified columns of Schedule VIII thereto the following items:
