BY-LAW

Number ______231-90

To amend By-law 193-83 (the regulation of traffic) for the removal of parking meters on Main Street South and Queen Street West

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 193-83, as amended, is hereby further amended:

(1) by deleting from the specified columns of Schedule XI thereto the following items:
