1. Subsection 5 of section 50 of the <u>Planning Act</u>, does not apply to the following lands:

- Part of Block 175 on Registered Plan 43M-1085, specifically described as Parts 1 to 9, all inclusive on Reference Plan 43R-20061, and
- Block 176 on Registered Plan 43M-1085, specifically described as Parts 10 to 20 all inclusive, on Reference Plan 43R-20061.
- 2. This by-law shall come into force upon approval thereof by the Regional Municipality of Peel.
